**C I R C U L A R**

It is for general information to all concerned that the Government of Arunachal Pradesh has launched a bank linked credit subsidy scheme on 3<sup>rd</sup> September 2021, the "ATMA NIRBHAR BAGWANI YOJANA". It is an 'Umbrella' scheme under the department of Horticulture. The scheme aims to cover the targeted group of youth/individual farmer, Self Help Group (SHG) and Farmers Producer Organization (FPO). The following components are available for the assistance:

Orange garden	Power Tiller (13 HP)	Manual Tool kit
Banana garden	Power Tiller (9 HP)	On Farm Aggregation Centre
Areca nut garden	Power weeder (6 HP)	Green House
Avocado garden	Brush Cutter	Shade Net House

Funding pattern and subsidy support consists of beneficiary contribution (minimum 10%), Bank finance (45%) and front ended subsidy from Govt. of Arunachal Pradesh (45%) with moratorium period of 12 months and 4 years as per the duration of crops.

The youth, individual farmer(marginal farmer & women), SHGs and FPOs of Changlang District who are interested in availing the scheme may visit the Office of the Department of Horticulture located in the District Head Quarter and the Circles for the details about the scheme and to collect the application format. The application as received by the department will be monitored and screened by the Circle Level Screening Committee (CLSC) at the Circle level and by the District Level Implementing and Monitoring Committee (DLIMC) at the District level. Only those proposals that fulfill the selection criteria will be forwarded to the concerned banks for sanctioning of loans. The timeline for completion of selection process of beneficiaries is by 30<sup>th</sup> September 2021.

Therefore, the interested farmer/SHG/FPO are required to submit their duly filled application form and proposal along with self-attested passport size photograph to the Horticulture Development Office in their respective Circle during the Office working hours on or before 20<sup>th</sup> September 2021 to avail the scheme.
